### HITRUST

- Self certification
- Audited via ISO or FedRAMP
- Outdated
- Not very prescriptive

Example: passwords

Covered entities should "implement procedures for creating, changing, and safeguarding passwords"

- Official certification
- Audited by HITRUST certified auditors
- Continually updated
- Prescriptive

Example: passwords

- Minimum length: 8 characters
- Complexity: 3 out of 4 character types
- Change requires 4 changed characters
- Password expiration: Every 60 days
- Reuse: Can't use last 6 passwords
- Etc.

### **Result: Many Payers and other Covered Entities are requiring HITRUST**

### Security to Implement Above Azure

- 1. Access Control
- 2. Identity & Authentication
- 3. Server lockdown
- 4. Encryption in transit, at rest
- 5. Vulnerability Scanning
- 6. Patching & Updating
- 7. Test environment

- 8. Change Management
- 9. Anti Malware & IDS/IPS
- 10. Event Logging & alerting
- 11. Incident Response
- 12. Backup & DR with testing
- 13. Cybersecurity Training
- 14. Third party audit

and more ... but these are the "top 14"

### Options for Deploying in Azure

#### **Do It Yourself** Time: 3-6 months

#### You need to

- 1. Learn Azure, HIPAA and HITRUST
- 2. Implement App level security and controls in Azure
- 3. Get certified
- 4. Provision your app in Azure
- 5. Support it

Project Hosts Does it Time: 1-2 weeks

#### You need to

- 1. Teach us all the aspects pertain to your application
- Get privileged access to control your app We need to
- 1. Provision your app in a certified Azure environment
  - . Provide on going support



#### Managing your Projects using Excel


- Frustratingly time consuming

### Managing your Projects using SharePoint


- Introduces collaboration features


